National Project Management Support Consultant (NPMSC) (Ref. No. ICS-067, Project ID No. P176088; IDA Credit No. 7102-LA)

The Ministry of Public Works and Transport (MPWT); Ministry of Agriculture and Forestry (MAF); Ministry of Industry and Commerce (MOIC); Ministry of Public Security (MOPS); Ministry of Health (MOH) and Ministry of Finance (MOF) of Lao PDR have received financing support from the World Bank's (WB) International Development Association (IDA) to implement the Southeast Asia Regional Economic Corridor and Connectivity (SEARECC) with a project duration of six (6) years starting from the middle of year 2022.

The NPMSC will support the Project Management Unit (PMU) to deliver its mandate for efficient and effective implementation of the SEARECC Project. The Consultant will work closely with the PMU team, the project subcomponents as deemed necessary and with the Department of Planning and Finance (DPF) of MPWT.

The total estimated input for this assignment is full-time (time-based) for 24 months with possibility of renewal based on satisfactory performance review and Project requirements. This assignment is expected to be started between Dec 2024 to Nov 2026.

The SEARECC Project Procurement Committee now invites eligible individual consultants to indicate their interest in providing the Services. Interested Consultant should provide information (CV, Expression of Interest, other supporting information, if any) demonstrating that s/he has the required qualifications and relevant experience to perform the Services. In order to qualify for this position, the candidates shall meet the following experience and competence requirements:

- Minimum a Bachelor Degree in Project Management, Project Planning, Business Administration, Transport & Logistics Management, or other relevant disciplines; a relevant training and/or certification on Project Management or M&E is an advantage.
- Work experience as an Assistant Project Manager or similar role (5 years).
- Minimum 5 years of proven experience in report writing and preparation, both Lao and English.
- At least 5 years of relevant work experience in projects funded by IFIs; such experience in projects funded by WB, ADB o other MPWT' projects' major financiers.
- Proficiency in Microsoft Office and project management software.
- Fluency in English and proficiency in Lao language.
- Detail oriented, highly organized and able to deliver several tasks simultaneously, without tight supervision & guidance
- Strong attention to detail and problem-solving skills
- Excellent organizational and communication skills, both verbal and written
- Ability to work with teams and under pressure with minimal supervision
- Experience working with multiethnic teams will be an advantage
